PET SITTING AGREEMENT

This is an agreement between Michelle Roth (dba Mitzvah Dog) and the dog owner whose name appears below (hereinafter called "Owner")

Mitzvah Dog agrees to provide loving care for your dog! Owner will provide all food for their dogs stay. Mitzvah Dog reserves the right to purchase additional food for your dog if needed. Owner agrees to reimburse Mitzvah Dog for additional food at pickup.

It is understood and agreed between Owner and Mitzvah Dog that this agreement contemplates that Owner will be in need of Mitzvah Dog's services at other times in the future. It is also understood that this agreement will apply to services performed in the future without the need to enter into another agreement. Owner will be notified of any price increases.

In the event that your dog needs emergency veterinary care while staying with Mitzvah Dog, Owner authorizes Mitzvah Dog to obtain emergency veterinary care by the veterinarian specified by Owner. If that veterinarian is unavailable at the time of the emergency, Owner authorizes Mitzvah Dog to utilize a 24 hour emergency animal clinic. Owner additionally authorizes all veterinarian costs that are incurred for their dog to be in the name of the owner. Owner must provide credit card information at the end of this agreement for emergency veterinary costs. Owner agrees to indemnify and hold harmless Mitzvah Dog from any liability arising from veterinary charges.

Mitzvah Dog's insurance company shall be liable for all claims of injury, death, damage or loss to Owner's pet. As further consideration for the services rendered, Owner agrees to waive

and release Mitzvah Dog and their representatives from any claim for injury, loss and/or death of Owner's pet. Owner agrees to be responsible for any claim for injury, loss and/or death of a representative of Mitzvah Dog caused by Owner's pet. Owner agrees to be responsible for damages done at the home of Mitzvah Dog by Owner's dog at the time of boarding and/or day care. Owner is responsible for attorney's costs for any legal action necessary for enforcement of this agreement.

Payment for sleep overs are due upon pick up of your dog. Payment for day care (if more than one day) are due at the end of that weeks care. Payment can be in the form of cash or check. A "return check charge" of no less than \$25 will be incurred for all returned checks. All fees paid are non-refundable.
